

2005 was a year of careful stewardship for the Kids First Fund.

This wonderful combination of mission focus, partnership orientation, and board experience has led the Kids First Fund to establish relationships with two highly-regarded organizations in Latvia: Latvia Children's Fund and Dardedze Center Against Abuse. Together this partnership will build a family shelter to serve abused children in Latvia's poorest region.

Your past support will allow construction of the shelter to begin in 2006. Our \$120,000 financial commitment will largely deplete our funds during the coming year. This is a good thing, as donations sitting in a bank account represent a lifeless resource. Strangely enough, our stakeholders only realize a "dividend" when money is spent — not saved — in service to children.

Upon reflection, 2005 was full of challenges for our world. The year began with the horror of the tsunami in south Asia, continued with ongoing violence in the Middle East, and concluded with natural disasters in Pakistan and the Mississippi Gulf. Donors throughout the world have met these needs by contributing a record amount of money and resources to emergency relief efforts.

During these troubled times, donor activity for the Kids First Fund has remained at consistent levels. Cash contributions for 2005 were in excess of \$19,000 and were \$100 above the total amount received during the prior year. 2004 fundraising activities were boosted by two events that generated an additional \$29,000. Fundraising activity during 2005 was limited to the Great Online Auction for Kids event that produced in excess of \$19,000. The donor base grew significantly during 2005, which resulted in more individuals donating money and a drop in average contribution size.

The Kids First Fund web site was the victim of a bizarre Internet scam, which involved the cloning of the site by a group of money launderers likely based in Russia. Essentially, the criminals copied the mission of our organization and the content of our site for their own illicit fundraising purposes under another name. The numerous cloned web sites were eventually shut down through weeks of nonstop effort. Unfortunately, the perpetrators have not been arrested and quickly found another web site to clone. The situation was unfortunate because it stole precious time from fundraising activities.

As is our policy, zero donor money was spent during 2005 on overhead, salaries and fundraising. Travel is always at the expense of individual board members. The Kids First Fund benefits from a great group of friends that donate their professional services. Matthew Frederick generously donates web site development and hosting. Melinda Caughill creates banner advertising and other collateral and never charges a cent. Amy Thomas has contributed her skills to design this annual report. Stephen Swenson is simply an amazing resource for all fundraising activities involving professional hockey. Your board of directors also generously volunteers time and donates money to support the organization. I thank all of you!

The Kids First Fund only exists because of its many friends. The most important of these are you — our donors. 2005 was a year in which we built a solid foundation by steadily growing our fund balance and establishing partnerships for our family shelter project. The journey has been made all the more enjoyable by your support, and the collective work of a wonderful board of directors. Thank you for the privilege of allowing me to lead these efforts!

NUMBERS HELP TELL OUR STORY

The following statistics describe the accomplishments of the **Kids First Fund** since its founding in 1999:

- Direct assistance for the care of abused children: approximately 380 children have received services since 2000
- Professionals such as police officers, doctors, legislators, judges and prosecutors, reached via the seminar series since 2001: 420
 - Donations received 1999 through 2005: \$258,000
 - Grants made 1999 through 2005: \$73,000
 - Future project expenditures planned: \$120,000
 - Cash account balance on December 31, 2005: \$185,000
 - Amount deducted in U.S. for overhead, salaries, fundraising and administration: \$0

MORE THAN 100 AIRLINE TICKETS AUCTIONED ONLINE

The Great On-Line Travel Auction for Kids sold more than 100 airline tickets during April 2005 and generated over \$19,000. Auction proceeds were boosted by a rebate of the online auction fees normally charged by eBay through its charitable Mission Fish initiative.

Airline tickets and hotel stays were listed with opening bids beginning at \$1. Participating airlines included: ATA, AirTran Airways, LAN Airlines, jetBlue Airways, Midwest Airlines, Song/Delta Air Lines, South African Airways, Sun Country Airlines, Swiss International Air Lines and Virgin Atlantic Airways.

Airbus North America donated a 1/100 scale model (over 2.5 foot wingspan) of its new A380 aircraft. Hilton Hotels, Intercontinental Hotels and Xanterra Parks & Resorts offered gift certificates for destinations throughout the United States available for auction. In addition, Cruise America, the nationwide RV rental company, donated a \$350 gift certificate. Please show your support for these donor travel companies!

IN MEMORY OF BOARD MEMBER DR. WILLIAM FRIEDRICH

Husband, dad, friend and Kids First Fund board member William Friedrich, Ph.D. lost a valiant battle against cancer on September 26, 2005. Bill's time as a board member was brief; he joined the Kids First Fund just one year earlier. The opening lines of his obituary define the spirit of this man, "We ask that no one wears black as this will be a joyous celebration of his extraordinary life."

Bill was a member of the pediatric and psychology staff at Mayo Clinic. In his work in clinical psychology at Mayo Clinic Rochester, he studied the impact of traumatic events on children, adolescents and adults. He earned his Ph.D. in clinical psychology from the University of North Dakota, an M.P.H. in behavioral sciences from the University of Texas, and completed a clinical psychology internship at the Texas Research Institute of Mental Sciences.

His research on the impact of traumatic events on children resulted in the development of the Child Sexual Behavior Inventory and the Adolescent Sexual Behavior Inventory, two scales that are used as outcome measures for treatment. Bill also participated as a team member for child abuse-related project work in Latvia, and other eastern European countries, through the Soros Foundation and as a Fulbright Scholar. In 2005 he received the Mayo Medical Faculty Service Award.



International travel was one of Bill's favorite hobbies. Bill was planning to join Jay Sorensen on a spring trip to Latvia, but declining health canceled his trip. His advice and counsel was instrumental in creating the philosophy and operating plan for the family shelter project in Latgale. He was always available to answer any question on the topic of child abuse prevention and treatment.

Survivors include his wife Wanda, daughter Hannah and son Karl. Bill was a fantastic father and husband; he was well respected by his friends and colleagues. Bill will be immeasurably missed.


KIDS FIRST FUND COMMITS TO ESTABLISH FAMILY SHELTER

The Kids First Fund has committed to a partnership with the Latvian Children's Fund and the Dardedze Center Against Abuse to establish a residential shelter for abused children and their mothers in the Latgale region of Latvia.

Board members participated in meetings and on-site visits in Latvia during 2004 and 2005 to facilitate the development of partner relationships and to learn more about the Latgale region. As part of its commitment with the two Latvia-based non-profit organizations, the Kids First Fund will provide up to US\$120,000 for the development of this new shelter. The site for

the facility is still under consideration and may involve the renovation of an existing structure or the construction of a new building in Latgale

The Latgale Family Shelter will provide residential shelter for mothers and children with a capacity for 24 persons. Latgale, a region in southeast Latvia, is among the poorest sections of the country, with unemployment in some areas exceeding 40 percent. In addition

to providing residential shelter for mothers and children, the Latgale Family Shelter will be an educational resource for child abuse issues. This function will provide outreach services through schools, police departments, medical professionals, social workers and clergy to assist early detection and prevention efforts.

Oversight of the project will be undertaken by a newly established Latvian-based non-government organization (NGO). This NGO, to be developed by the Latvia Children's Fund, will include representatives from the three founding organizations. The Dardedze Center Against Abuse (Riga) would be responsible for shelter operations and administration. The shelter is expected to open by February 2007.

Red Weather hits bookstores May 2006 and will be published by Shaye Arehart Books, a division of Random House. The following description is from the author's web site at **paulstoutonghi.com**:

The setting for the novel is Milwaukee, Wisconsin — home to an array of breweries and abandoned factories and down-on-their-luck Eastern European immigrants. Revolutions are sweeping through the nations of the Eastern Bloc. Communism is unraveling. And nobody feels this unraveling more piquantly than Yuri (the novel's Latvian character) whose parents mortify him with their stubbornly foreign accents and habits.

But when Yuri falls in love with Hannah Graham — the daring and dangerous daughter of a prominent Milwaukee socialist — chaos ensues. Within weeks he has joined the staff of the Socialist Worker, and his ideological betrayal will have more serious consequences than breaking his parents' hearts.

Red Weather is by turns funny and bittersweet, tinged with a rueful comic sense that is at once reminiscent of Michael Chabon's The Mysteries of Pittsburgh and Khaled Hosseini's The Kite Runner.


Arturs was a founding member of the Kids

KIDS FIRST FUND NOW ACCEPTS APPRECIATED STOCK AS GIFTS

If you are planning to make a contribution to the Kids First Fund, you might consider donating appreciated stock from your investment portfolio instead of cash. Your tax benefits from the donation can be increased and the Kids First Fund now has the ability to receive donated stock.

Donating appreciated stocks that have been held for more than one year can be a wise philanthropic decision. This gift enables you to 1) make a significant gift to the Kids First Fund, 2) receive a charitable donation deduction on your income taxes, and 3) bypass capital gains taxes. To receive the full benefit when donating appreciated stock, it's vital you donate the stock itself. Do not sell it first and donate the cash proceeds.

There are special limitations that apply to this method of making charitable contributions. Prior to making any contribution, check with your tax professional. At the very least, read IRS Publication 526 for additional information on the contribution limitations. If you get the green light — please refer to the following information to donate stock held by a broker:

- **1.** Contact your broker about making a gift of stock to the Kids First Fund, Inc.
- 2. Choose the long-term appreciated stock and determine the number of shares to be transferred. The easiest and quickest way to complete a gift of stock held by a broker is through a "back office electronic transfer." Provide the following information to your broker:

3. Contact the Kids First Fund at 414-961-1939 and inform us of the gift to ensure proper acknowledgement.
